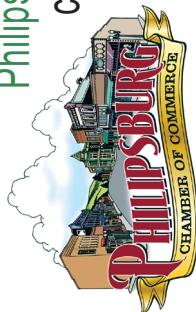

TERMS FOR ADVERTISERS

- The authorized signature on official forms, confirmation eMail, telephone or eMail reservations constitute a contract between the entities.
- Early Bird Space Reservation amount is due & payable to the **Philipsburg Chamber of Commerce** by **September 30, 2026**; otherwise, a revised invoice for the full price of the ad space is sent on **October 01, 2026** and due upon receipt.
- Ad Design amount is due & payable to **Quantus Design** by **September 30, 2026**.
- Quantus provides two (2) proofs via eMail free of charge for changes or new ads and \$10 for each additional proof.
- The Advertiser is obligated to reserve and pay by the deadlines above to receive stated discount or placement.
- The Advertiser is responsible for all collection expenses.
- Ad Space Reservation not paid in full by **September 30, 2026** is sold on a first-come, first-serve basis.
- Partial payments are not accepted and will be returned.
